Mr. Steinberg asked about the food service contract and transportation renewals. Ms. Baxley responded.

Mr. Steinberg read the donation into the record.

X. OLD BUSINESS

Mr. Scher asked about the status of construction projects. Ms. Baxley responded.

Ms. Molinelli asked for an update on Ms. Safari's Fulbright experience in Finland. Dr. Gundersen will look for Ms. Safari to come in during the board retreat. Ms. Molinelli would like a written report as well.

XI. NEW BUSINESS

Dr. Gundersen wished the teachers a very happy Teacher Appreciation Week during this remote learning time. The governor has closed schools till the end of the year. The district has a lot of work to do to finalize plans for graduation. It all hinges upon the guidance that we get from Trenton.

In the coming days the governor will be meeting with the Commissioner of Education. We will follow up with our parents when we get their input.

Mr. Steinberg asked about the bees. Dr. Gundersen told the board that they are being fostered at a relative of the biology teacher.

Ms. Molinelli asked the student representatives what they would like to see for graduation. Kaila said a virtual graduation might have to happen but would rather see a traditional ceremony. As she is not a senior, she feels that she is not the right person to weigh in.

Sean said the perfect graduation in this scenario would be personal with live streaming and social distancing. Most seniors do not want a virtual graduation.

XII. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments and are limited to five minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise and state their name and address.

Diane Scozzafava from Hillsdale asked what would be the rationale for not attempting to social distance our students on the field. Dr. Gundersen explained the governor's school closure prohibits anyone to go on campus. The district needs to wait to see what they will be permitted to do. Hopefully, the governor will provide a safe way to accomplish graduation.

Dana Porrazzo from River Vale believes in waiting for guidance from Trenton but she sees online that other districts have reached out to encourage their students. Is there anything in the works for the school to do something publicly. Mr. Puccio sent an email about the Friday night lights to recognize the seniors. Dr. Gundersen apologized that she feels the staff is not celebrating seniors. The signs at Pascack Hills came earlier than the signs at Pascack Valley. The Friday night lights at Pascack Hills are more visible because there is a road to drive thru to see the field but at Pascack Valley the field is behind the school and we are prohibited from opening the campus. The school will be doing more in the next six weeks to celebrate our students.

LeeAnn and Alex Menendez from River Vale are seeing other Bergen county schools doing things. Ridgewood has names on the field and Paramus is doing something as well. Both of her students are upset. Just saying that the school is working on it doesn't help. What has been done so far. Dr. Gundersen responded that the district is putting measures in place on how to best move forward with the senior awards ceremony. Now that school

has been closed the plans that were in place have to be changed. A fully traditional ceremony will not be possible. We are hoping to have guidance from the Department of Education. Ms. Menendez feels there needs to be more attention to the seniors.

Rachel Feder from River Vale wants to know if it would be helpful for parents to reach out to the governor's office or the Department of Education to address the subject of graduation in an effort to have a traditional graduation. Is it important for him to hear from them? Dr. Gundersen replied that while she is welcome to do that the decision will be based on what the experts are telling him is safe.

Ehren Dimistry from River Vale asked if the state has put limitations on using other facilities or properties. Dr. Gundersen replied that at times the school can conduct ceremonies elsewhere. An open-air venue would probably be best. However, it would not be prudent to have graduation at an offsite location. It would be going against the spirit of the legislation.

Rashella Roznitsky from Hillsdale reiterated what the others had been saying. It would be great to have a traditional ceremony. Can we have it in a park or at the church across the street. Anywhere is better than virtually. Dr. Gundersen had considered a staggered graduation but is waiting to hear the guidance from the state.

Jennifer Pacca from Hillsdale asked can we do something on the front of the property; pictures of the students or something that can be seen. Dr. Gundersen said something is in the works for that.

Heather Manspeizer from River Vale feels that the anxiety plays on the parents. The unknown is scary. The communication is key. When will we know, will options be presented, who will vote on the options are all questions? Dr. Gundersen affirmed that the unknown causes anxiety. Once students break social distancing it is problematic. It is very complex. We will make this as memorable for the Class of 2020 as possible, in a safe way.

Dana Mattessich from Hillsdale stated that after June 16, seniors are no longer our students. If the governor says June 30th would be an acceptable date, would the district make an exception. Is there any consideration to push it past that date? Dr. Gundersen responded.

Alfredo Alvarado from River Vale said Pascack Hills is doing a teacher video. Pascack Valley is not getting clear answers on what they are doing. Can parents sign waivers to push graduation off into the summer. Dr. Gundersen responded and repeated that he is looking for guidance from the state. He asked if they go after the 16th could the school board pay for an insurance policy for that one-day event. Is the board considering something between now and then for the kids?

Kirstie Levine from River Vale commented that the Daytona Speedway is being used in Florida. Could we potentially explore other venues off site? Perhaps the Meadowlands.

Jaime Caruso from River Vale commented that her daughter was inducted into NHS via a virtual ceremony and was disappointed. While she is happy to be recognized it was disappointing.

Ruta Fiorino from Hillsdale asked how the students can say goodbye to their teachers. Dr. Gundersen replied.

Dana Porrazzo from River Vale asked when the caps and gowns would be delivered and also asked about the workload for the students and whether grading would be pass/fail. Dr. Gundersen replied that the caps and gowns are on their way. The senior lawn signs are expected shortly. Dr. Bachenheimer replied that we are not pass/fail. They are encouraging parents to log into genesis and to reach out to the student's teacher if your child is struggling.

Karen Jones from River Vale wanted to know if she sent a thank you to the teacher to the school would it be forwarded. Dr. Gundersen responded.

Bailey McNamara, a senior from Pascack Valley, wondered what will happen with the money raised through fundraising.

Ms. Molinelli appreciated all the comments and feedback.
